**Program Guidelines:** The Jewell P.R.O.G.E.N.T. Program will grant up to \$150 / single business or \$50 per business for group promotion (on a 50/50% match basis with the business owner(s) for business advertising and promotion. The program funds are available until the pool of money allocated for the grant program is exhausted. If promotion projects are submitted for pre-project approval, approved project must be completed within three months from the date the project is approved in order to qualify for reimbursement. The PROGENT Grant is limited to one grant per year for a single business. Businesses are not limited in the number of group promotions they can participate in during the year. (Promotion credit for JADE must be included in all promotions considered for PROGENT Grant.)

Projects that have accompanying Main Street/S.E.E.D./JADE Promotion Committee consultation and have not been granted funds previously by JADE will receive priority. Purchases should be made locally if possible.

**Application Directions:**

1. Current business membership in JADE is required. (Group promotion businesses must be current JADE Business Members to receive PROGENT Grant funds.)
2. Fill out this application and mail to JADE PO Box 475, Jewell, IA 50130 (Include copy of promotion billing and a copy of promotion if in written format.) (Grants submitted for pre-approval must be accompanied with written advertising quote or price sheet.)
3. The promotion review committee will determine if your project is eligible and will notify you of their decision.
4. Upon completion of project, submit copies of receipts, media billing, and copy of written media (if appropriate) to JADE.
5. Your business(es) will be reimbursed 50% of the total amount of the promotion or an amount not to exceed \$150 for a single business application or \$50 per business on a group promotion project. Project invoices must accompany grant application.
