Effective January 1, 2022, the salary of each Council Member shall be \$50.00 for each meeting of the Council attended, payable quarterly. Lorenzen seconded the motion. Roll Call 4-1, with Roethler voting nay. Motion carried.

SIDEWALK COMMITTEE: Winborn made a motion to approve Resolution 21-07, adopting the sidewalk inspection and repair policy. Outzen seconded the motion. Roll Call 5-0. Motion carried.
