

The Jewell City Council met in a Regular Session May 11, 2021, at the Jewell City Hall starting at 7:00 p.m. Mayor Reiter called the meeting to order with Council Members: Outzen, Roethler and Young present. Absent – Lorenzen and Winborn.

APPROVE MINUTES OF APRIL 26, 2021, REGULAR SESSION:

Outzen made a motion to approve the minutes of April 26, 2021, Regular Session.

HEADWATERS OF THE SOUTH SKUNK WATERSHED MANAGEMENT AUTHORITY:

Story County Board of Supervisor Linda Murken and Hamilton County Board Supervisor Rick Young were present to explain the proposed 28E agreement and answer any questions. Roethler made a motion to approve the 28E agreement. Outzen seconded the motion. Roll Call 3 – 0. Motion carried. A City of Jewell representative to the board will be approved at the next city council meeting.

NOTICE OF HEARING ON PROPOSED ANNEXATION OF LANDS INTO HAMILTON COUNTY DRAINAGE DISTRICT NO. 71 MUD LAKE:

Hamilton County Board Supervisor Rick Young provided a brief history of the drainage district and the proposed needed repairs. A public hearing has been scheduled for May 25, 2021 at 1:30 pm at the Hamilton County Courthouse in Webster City, Iowa. No action was taken.

JEWELL JUBLIEE:

a. Young made a motion to approve the liquor license for the Jewell Jubilee event. Roethler seconded the motion. Roll Call 3 – 0. Motion carried.

b. The fireworks permit will be completed and reviewed at the May 24, 2021 city council meeting.

c. The Jewell Jubilee committee reviewed the planned events with the City Council. The Main Street BBQ will be Friday, June 11th at 5:00 p.m. The parade will be Saturday, June 12th at 10:00 a.m. with events to follow in the park. A beer tent, entertainment and games will be Saturday night on Main Street.

FIRST READING OF ORDINANCE 289, AMENDING AND ADDING TO CHAPTER 69 PROVISIONS PERTAINING TO PARKING REGULATIONS: *Outzen made a motion to approve the first reading of Ordinance 289. Young seconded the motion. Roll Call 3 – 0. Motion carried.*

FIRST READING OF ORDINANCE 290, AMENDING CHAPTER 70 PROVISIONS PERTAINING TO TRAFFIC CODE ENFORCEMENT PROCEDURES: *Young made a motion to approve the first reading of Ordinance 290. Roethler seconded the motion. Roll Call 3 – 0. Motion carried*

WOOLSTOCK MUTUAL TELEPHONE SERVICES: *Councilmember Young spoke with the Woolstock Mutual Telephone Company. They are not interested in moving their antenna from the Co-op to the city water tower. They might in the future consider installing a second antenna on the city water tower. No action was taken.*

448 EAST LANE: *Mayor Reiter showed the City Council current pictures of the property. He mailed the homeowner a letter telling her to stop constructing and remove any posts that have been installed for a non-permitted fence. The situation will be reviewed with City Attorney Deppe and EJS Police Department. No action was taken.*

TREES: *The City Council reviewed pictures of trees on Collins Street. Outzen made a motion to ask Public Works Director Bernie Bell to get quotes for tree trimming and removals throughout the City of Jewell. Roethler seconded the motion. Roll Call 3 – 0. Motion carried.*

2020-2021 BUDGET AMENDMENT:

a. The City Council reviewed the final proposed amendments.

b. Young made a motion to approve the publishing of the Notice of Public Hearing for the 2020-2021 budget amendment. Outzen seconded the motion. Roll Call 3 – 0. Motion carried. The public hearing is scheduled for Monday, May 24, 2021 at 7:30 p.m. at Jewell City Hall.
