**ANNUAL FINANCIAL REPORT:** The 2022-2023 Annual Financial Report was presented to the Council. There was \$1,744,464 total revenue for the year and \$1,414,251 in expenditures for the year. The City has a revenue debt of \$1,336,540 still outstanding.

**CONCERT IN THE PARK:** The Council tabled this agenda item until Gunderson could be present to give specific details regarding the fundraising event.

**BUILDING PERMIT INSPECTOR:** Mayor Reiter informed the Council that he wishes to remove himself from signing off on building permits. The Council will decide in January who will be the second signer on the permits.

## 2023-2024 BUDGET

- Employee Wages-The personnel committee met and discussed the employees' job performance and decided to recommend a 3% wage increase with the possibility of up to 2% more for merit. The committee recommended Dave Osmundson to get a 3% wage increase and Regina Beaune a 5% wage increase. Terry Anderson's wage increases are tied to his attaining certificates and the police board votes to approve police wages. Boor made a motion to give Beaune a 3% wage plus an additional 2% merit raise and Osmundson a 3% wage increases. City Attorney Justin Deppe shared his belief that the difference in wage increases could be detrimental to morale. The motion died for a lack of a second.
- Energy Costs-Alliant Energy has proposed an increase in rates of 15-20%, which would be an additional \$10,845-\$14,460 in expenses to the city.

**RESOLUTION 23-30:** Winborn made a motion to approve Resolution 23-30, which opposes the magnitude of Alliant Energy's rate increase and urges the Iowa Utilities Board to address Alliant's high, rising, and unreasonable costs that are imposing serious hardship for low and moderate-income households and require rate-regulated utilities to conduct integrated resource planning and competitive procurement to ensure all utility investments are justified and cost-effective. Roethler seconded the motion. Roll Call 4—0. Motion carried.
