The Jewell City Council met in regular session Monday September 23, 2024 at the Jewell City Hall starting at 7:00 p.m. Mayor Mickey Walker called the meeting to order with Council members: Scott Rohloff, Aaron Boor, Stacy Alsager, Loyal Winborn and Steve Butler present. City Attorney Justin Deppe was in attendance for the meeting along with members from the pool committee and some residents of Jewell.

APPROVE CONSENT AGENDA: Winborn made a motion to approve the consent agenda which included:

- Agenda for September 23, 2024
- Minutes from September 9, 2024
- Claims from September 23, 2024

Boor seconded the motion. After discussion about the minutes Winborn withdrew his motion. Butler made a motion to change the minutes to describe the "Police Board City of Jewell Representative" item more accurately. The minutes currently state, "The Police Board will keep Steve Butler and Mayor Walker as the representatives from Jewell" and will be changed to "The City of Jewell will keep Mayor Walker and Steve Butler as the representatives from Jewell". Serving on the Police Board are the Mayors of Jewell, Ellsworth, and Stanhope as well as one council person from each town who is appointed by the mayors to fill the position. Stacy seconded the motion. Roll Call 5—0. Motion carried. Winborn made a motion to approve the consent agenda reflecting the changes previously mentioned. Alsager seconded the motion. Roll Call 5—0. Motion carried.

RESOLUTION 24-29: Boor made a motion to approve Resolution 24-29 which appoints Scott Rohloff, Stacy Alsager, Annette Babcock, Travis Anderson, and Dave Trask as members of the Park Board. Stacy Alsager shall be appointed as the chairperson of the Park Board. Butler seconded the motion. Roll Call 5—0. Motion carried.

ASH TREES: Multiple ash trees have fallen throughout town. The city inspected dead trees and compiled a list of the most urgent to remove. Alsager made a motion to send a letter to the residents with trees on the list. All trees should be removed by Monday, December 2nd. The resident may get on a list by calling City Hall by October 4 to have tree(s) removed for the price of \$750/tree by Robb's Tree Service. Butler seconded the motion. Roll Call 5—0. Motion carried.

IOWA SELECT FARMS: Alsager made a motion to approve Iowa Select Farms to set up near the Jewell Market on Wednesday December 11th from 8:00 a.m. – 9:00 a.m. to pass out free pork loins for part of Operation Christmas Meal. Winborn seconded the motion. Roll Call 4—1; Boor-nay, Winborn-aye, Alsager-aye, Rohloff-aye, and Butler-aye. Motion carried.

GROCERIES AND GUITARS EVENT: The Jewell Market is having an event called Groceries and Guitars on September 27th from 4:30 p.m. – 8:00 p.m. and requested permission to block off Collins Street half a block north of King Street. Rohloff made a motion to approve the request. Butler seconded the motion. Roll Call 5—0. Motion carried.

POOL PHASED APPROACH: Rick Young was present on behalf of the S.H.A.P.E pool committee to request a waiver for the pool's bath house. Young also discussed the possibility of bringing the current bath house up to compliance, in which case there would be no need for a waiver. Boor made a motion to complete and sign the waiver. There was no second motion, so the motion died. City Attorney Justin Deppe did not feel it was appropriate to sign the waiver, seeing as it was not filled out. Butler made a motion for the city to contact the State of Inspection and Appeals to see if they could inspect the bath house in order to let us know exactly what needs to be done in order for it to be compliant. Rohloff seconded the motion. Roll Call 5—0. Motion carried. Alsager made a motion to set a pool work session meeting on Tuesday, October 29 at 7:00 p.m. Winborn seconded the motion. Roll Call 5—0. Motion carried.

HANDICAP PARKING ON MAIN STREET: The possibility of adding handicap parking spots to Main Street will be discussed further at the October 14 council meeting.

ADJOURN: Winborn made a motion to adjourn the meeting. Alsager seconded the motion. Roll Call 5—0. Motion carried. The meeting was adjourned at 8:33 p.m.
