amaze the council. One statistic shared by Chief Hendrickson was for the 51 medical calls: from the time the page goes off to the time EMS is on scene is 8.46 minutes and the Iowa average is 15-20 minutes! Thank you to all Jewell Fire and Rescue members for your exemplary service.
